Audit Findings

Audit Narrative

A PREA audit of the Westhab Inc. Windham Residents was conducted November 8, 2018 by Chris Sweney, Certified PREA auditor. As part of the audit a full tour of the facility was conducted along with document reviews and staff and resident interviews. The tour included all area of the facility including resident rooms, bathroom/shower areas, laundry, the control room, and administrative offices. Pre-Audit posters where observed in all housing and common areas. The auditor did not receive any written correspondence from residents or staff prior to the onsite visit.

Following the tour the Senior Case Manager provided the auditor with a roster of staff assigned to the facility. A total of three (3) random staff interviews were conducted. Random staff interviews included questions about PREA training they had received, policies that are in place, unannounced rounds and first responder duties and responsibilities. Targeted staff interviews included the Director of Supportive Housing, Senior Case Manager/PREA Coordinator, Program Volunteer, and NYDOCC-SID Investigative Officer (by phone) responsible for PREA related investigations. A total of seven (7) formal staff interviews where completed.

Following staff interviews the Senior Case Manager provided the auditor with a roster of all (40) forty residents including four (4) parolees assigned to the facility. Residents were randomly selected by the auditor. One resident who spoke limited English was interviewed. One resident where identified that he was hearing impaired was interviewed. There were no residents who identified as lesbian, gay or transgender. A total of ten (10) formal resident interviews were completed. The Windham Residents reported no allegations of sexual abuse or harassment in the past twelve months.

Facility Characteristics

The Windham Residents is a transitional living facility located in Yonkers NY. The Windham Residents has thirty-nine individual living units with five units reserved for parolees released from the New York State Department of Corrections and Community Supervision. Residents on parole remain at Windham Residents up to one-hundred and twenty days. Each resident is assigned a Case Manager to assist them in obtaining community services/resources as they move toward more permanent housing.

cavity searches for any reason. If it is necessary to do any type of search of a parolee resident, the resident will be searched by their parole officer away from the facility. The Windham Residence does not restrict female residents'access to available programming due to a lack of female staff.
The Windham Residence has policies and procedures that enable residents to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing their breasts, buttocks, or genitalia. Windham Residence policies require staff of the opposite gender to announce their presence when entering the floor and resident rooms. Resident interviews indicated that both male and female staff are respectful for their privacy and make announcements as required by policy.
Westhab staff do not, for any reason, search or physically examine a transgender or intersex residents for the sole purpose of determining the resident's genital status.
All staff is trained how to conduct pat-down searches, and searches of transgender and intersex residents, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs.

Westhab Inc. does not conduct any type of criminal or administrative investigation, but fully cooperates with the New York State Department of Corrections and Community Supervision, Office of Parole, Office of Special Investigations, and/or City of Yonkers Police Department to ensure that these agencies have the proper information to conduct investigation(s). The Office of Special Investigations and/or City of Yonkers Police Department are the law enforcement authority for the Windham Residence.

If staff receives information that a resident was sexually abused, or is in danger of being sexually abused, the PREA Coordinator will immediately contact the Director of Supportive Housing, Contract Monitor and Office of Special Investigations, and/or City of Yonkers Police Department to inform them of what has occurred, and shall follow their instructions and guidelines to ensure the safety of the resident.

Investigators from the New York State Department of Corrections and Community Supervision Office of Special Investigations receives specialized training which includes techniques for interviewing sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and criteria and evidence required to substantiate a case for administrative action or prosecution referral. Documentation of specialized investigator training is maintained by the NYDOCC.

The Windham Residents assesses all residents upon intake for risk of being sexually abused by other residents or sexually abusive toward other residents. Intake screening generally take place within 2 hours of arrival at the facility.

The assessment is conducted using the PREA Screening Interment. The PREA Screening Interment considers, whether the resident has a mental, physical, or developmental disability; theage of the resident; the physical build of the resident; whether the resident has previously been incarcerated; whether the resident's criminal history is exclusively nonviolent; whether the resident has prior convictions for sex offenses against an adult or child; whether the resident is or is perceived to be gay, lesbian, bisexual, transgender, intersex, or gender nonconforming; whether the resident has previously experienced sexual victimization and the resident's own perception of vulnerability.

Westhab Inc. will protect all residents and staff who report sexual abuse or sexual harassment or cooperate with sexual abuse or sexual harassment investigations from retaliation by other residents or staff. The Senior Program Manager/PREA Coordinator is responsible with monitoring retaliation.

Multiple protection measures are employed, removal of alleged staff or resident abusers from contact with victims, and emotional support services for residents or staff that fear retaliation for reporting sexual abuse or sexual harassment or for cooperating with investigations.

For at least 90 days and then as needed following a report of sexual abuse, the Senior Program Manager/PREA Coordinator will monitor the conduct and treatment of residents or staff who reported the sexual abuse to see if there are changes that may suggest possible retaliation by residents or staff. The Senior Program Manager/PREA Coordinator will act promptly to remedy any perceived retaliation. Items the facility will monitor include: any resident disciplinary reports, program changes, negative performance reviews and reassignments of staff.

The Senior Program Manager/PREA Coordinator will continue monitoring beyond 90 days if the initial monitoring indicates a continuing need.

In the case of residents, monitoring will also include periodic status checks which will be assigned to staff as a daily task and will occur no less than once per shift. Documentation will be completed to describe monitoring and any action taken.

If any other individual who cooperates with an investigation expresses a fear of retaliation, the agency will take appropriate measures to protect that individual against it using the same procedures noted above.

Windham's obligation to monitor will terminate if it is informed by investigators that the allegation was unfounded.

During the past twelve months there were no incidents requiring such monitoring for either residents or staff.
